#### **(6) Examining Translation of presbytery official documents and the presbytery constitution.**

- A. Purpose: publishing the church order of CBPCP in bilingual (Khmer and English) according to depending the Church Order of KAPC.
- B. Contents: Creed, Government, Public Directory of Worship and The Rule of Discipline and Documents( Church present situation and several report forms, the form of the application of membership).
- C. Translated persons: Supervisor-moderator & clerk, Members- Timothy Div, Manil Ek Assisted translator- Mr. Sovanna Doun, Vichea Cheap
- D. The due date of translation ending- January 31 2015
- E. The Examination committee should review the first draft and submit the bilingual book of church order to the presbytery until the next meeting(January19-22 2015). The examination committee should examine all things for publishing.(1/30/2015).

#### **(7) Obligation of Each Court**

- 1) Make report of churches situation and finance.
- 2) Cooperate of growing churches both member and spiritual.
- 3) The order of meeting should be received at least one week before regular meeting for better decision and discussion.
- 4) If there is any change of church administration, the Presbytery should be informed.
- 5) Any new elders that nominated by churches should be anointed by presbytery.
- 6) The acceptant of assistant member of presbytery member should submit at least 1 week before meeting.
- 7) The goal is that within few years, the Cambodian should take turn to over the presbytery leadership committees.
- 8) Court can organize revival meeting by inviting and cooperating with other member those are nearby.
- 9) The giving offering after meeting is not for personal use but for the glory of God in ministry or revival meeting.
